#### **Lake District Calvert Trust**

The Lake District Calvert Trust is a registered Charity which enables children and adults with disabilities, along with their families and friends, to achieve their potential through the challenge of outdoor adventure.

Research shows that the Calvert Trust Experience provides something of much longer-term value than just an adventurous few days spent in the outdoors

We work with people who have a disability – from mild to the most profound disability - using uniquely adapted facilities that have been continuously developed over 45 years. No matter the level of disability, our visitors can share the same adventure as their able-bodied peers and relatives. The Programmes and pioneering approach are delivered by an equally unique staff team with skills and experience found nowhere else.

Lake District Calvert Trust has grown from being the UK's first dedicated Activity Centre for people with disabilities, to welcoming around 3,500 visitors to stay each year. These include



individuals, family groups, specialist schools, accessible sports clubs, disability charity groups, supported living organisations and care homes, from across the UK.

Our specialist facilities are also well used by the local community, with over 12,000 visits to our hydrotherapy pool in a year. Our riding stables ran nearly 1,800 sessions for local riders and host the local Riding for the Disabled Association group.



## The Original Calvert Legacy ... William Wordsworth

In 1794, orphaned and without anywhere to live, William and Dorothy Wordsworth were given their first home, just outside Keswick, rent free, by the Calvert Family. Raisley Calvert was a childhood friend of Wordsworth and believed in Wordsworth's potential as a poet. Raisley died, aged 21, of tuberculosis. In his Will, he left Wordsworth the legacy of £900 that was to give him the independence that would allow him to devote himself entirely to poetry and become the Poet Laureate we know today. Wordsworth immortalised his friend's legacy in published word:

'Calvert! It must not be unheard by them who may respect my name, that I to thee owed many years of early liberty'

### Oliver's Story

Oliver requires specialist care having suffered a brain injury when he was two days old which left him with sight loss, cerebral palsy, epilepsy, autism and learning difficulties.

Visits to the Calvert have allowed him to take part in activities such as canoeing, abseiling and rock climbing and showed him "nothing is impossible", according to his mother, Sarah

# How to Leave a Gift in Your Will

- There are three main types of gift you can include in your Will:
  - Residuary gift: a share of whatever is left after all debts have been paid and other gifts made,
  - Pecuniary gift: a fixed sum of money, or
  - **Specific gift:** a particular item, for example your house.
- There is no inheritance tax payable on any gift and you may qualify for a reduced rate of inheritance tax.
- You may make an addition to an existing Will via a Codicil form which is stored with your Will.
- We recommend you speak with a solicitor or professional Will writer

### **Suggested Wording for Your Will**

It is very simple to make a gift to the Lake District Calvert Trust in your will. Should you decide to make a gift of a fixed amount, your professional adviser may find the following wording helpful:

'I/We give to The Lake District Calvert Trust of Little
 Crosthwaite, Keswick CA12 4QD, Registered Charity
 Number 270923, to be applied for the general purposes
 of The Lake District Calvert Trust, the sum of (amount in
 figures, amount in words) and I/we direct the receipt of a
 proper officer for the time being of The Lake District Calvert
 Trust shall be a complete discharge to my/our Executors.'

If you would like to leave a share of the residue of your estate, set out below is suggested wording which your professional adviser can use:

'I/We give all/a share of (please state fraction/percentage)
the residue of my/our estate to The Lake District Calvert
Trust of Little Crosthwaite, Keswick CA12 4QD, Registered
Charity Number 270923, to be applied for the general
purposes of The Lake District Calvert Trust, and I/we direct
the receipt of a proper officer for the time being of The
Lake District Calvert Trust shall be a complete discharge to
my/our Executors.'

### **Examples of Gifts**
